If player does not check in Sun., deposit amount will NOT be refunded, and will be applied towards trophy fund.

FEES, REGULATIONS & CRITERIA

All entry fees include \$30 Green Fee + \$10 Admin Fee (does not pertain to Junior event)

Once brackets are posted, no one can purchase a spot. Players can be added after the entry deadline if there are spots available. There will be a **\$40 late fee** charged per player that signs up past the deadline date.

Any player withdrawing from the tournament between Thursday Oct. 16 and Friday Oct. 24th will be charged a **\$10 withdrawal fee**.

Any player withdrawing from the tournament after October 24th, their league operator can sell the spot to equal ranking and from the same charter holder. If the spot cannot be sold then the player will be forfeit the entry fee.

All players must have played in 25% of scheduled league matches as of the Tournament date. (does not pertain to Junior event)

Players under the age of 21 must play in Open Elite or above. A Junior player can not play in the regular tournament & the junior tournament.

Women's Apex winner for 2 consecutive years, play in minimum of Open Elite.

Note: The following criteria has been put in place by the Rocky Mountain operators. If a qualified VNEA player has an operator not using Compusport to establish a CSR, they can still play as long as they have qualified in a VNEA league. If the player does not have a CSR, but does have another rating by a different pool assoc. that value might be able to be converted to a useable CSR. If that does not apply, any past Rocky Mountain tournament experience that can be referenced and used to determine appropriate placement. If no prior rating or tournament history exists, the player will be assigned a default CSR: **1700 for men and 1600 for women.**

Player ability assessment may be determined by the Rocky Mountain Operators Committee by any of the following criteria: a) Players skill rating (CSR), b) Review of previous tournament performances, c) Examination of overall local league ratings, d) Known ability.

Any player who signs up for improper division will be ejected from tournament at point of discovery. The player will forfeit any prize money and entry fee. All decisions made by Rocky Mountain Operator Committee are final.
